# **Chapter I Introduction**

### 1.1 Research Background

Charles Dickens was an English writer and social critic. He created some of the world's best-known fictional characters and is regarded as many as the greatest novelist of the Victorian Era. *Oliver Twist* is the second most-well known works that Charles Dickens ever wrote, it was published in 1838. It remains popular and also adapted into several films. *Oliver Twist* is best known for its exposing the cruel treatment of the many orphans in London in the 19<sup>th</sup> century story.

By reading this inspiring novel, the writer feels enchanted on the plot of the novel. The story was influential in bringing to the cruel treatment of poor and orphans in Dickens's time. The author describes the struggle of Oliver Twist being an orphan where he always gets mistreatment from people around him. The writer found out many moral values hidden in the story that can teach the readers to be a better person in real life
