The presence of a code of ethics itself is functioning as a means of direct control for the conduct of the employee or official work. In this context , the more important is that the code of ethics is not just there , but also assessed the level of implementation in reality . Even based on the assessment of the implementation , these codes are then developed or revised to keep in accordance with the demands of changing times .
