Internal conflicts are the psychological struggles within a character, such as dilemmas, emotional distress, and cognitive dissonance. On the other hand, external conflicts involve the character's challenges and interactions with other people and their surroundings (Edward H. Jones, 1968). Understanding these conflicts helps to reveal how characters deal with various issues and what these struggles say about their psychological state.

Conflict is closely related to human psychology, as it often triggers various emotional and cognitive responses. These responses can be examined through the lens of psychoanalytic theory, which was developed by Sigmund Freud. Psychoanalytic theory delves into the unconscious mind, repressed emotions, and internal conflicts, providing a framework for understanding the psychological dimensions of a character (Freud, 1923).

From definition above, literary work viewed as psychological phenomena, the psychological aspects will appear through the characters if the text likes drama or prose (Endaswara, 2008). Referring from the previous explanation, the researcher is interested in finding a psychological concern reflected in a novel. It becomes challenging for the researcher to know more about history and psychological theory through a literary work. One of the novels significantly presenting the issue of psychology *is "Walk Two Moons"* by Sharon Creech. The researcher intends to present main character's psychological approach in handling mental conflict in literary research and would like to explore some important problems related to psychology. By a novel entitled *Walk Two Moons*, this study

focuses on the main character in "Walk Two Moons" and their psychological journey in handling mental conflict. The novel's protagonist, Salamanca Tree Hiddle, undergoes significant internal conflicts as she grapples with grief, identity, and emotional turmoil. By applying psychoanalytic theory to Salamanca's character, this study aims to uncover the psychological mechanisms she employs to cope with her mental conflicts.

conflict. Therefore, by exploring Salamanca's character, the conflicts and psychological aspects, the study will use conflict theory, as explained by Robert Stanton (1965), to look at the main character's conflicts, distinguishing between external and internal conflicts. It will also apply Sigmund Freud's (1923) theory of the id, ego, and superego to see how these psychological elements affect how the character deals with conflicts. The focus will be on how the main character's thoughts and behaviors are connected to her approach to conflict.
